2 **MINUTES**

MATTERS ARISING

Reference was made to schemes which had been considered at the last meeting and, in particular, those which had been deferred for more information.

DECISION:

- (1) That the following scheme be approved in principle, including the installation of traffic signals, subject to the cost of the scheme being reported to the next meeting of the Panel:-
 - IT859 Oak Road, Rivenhall Traffic signals and footpath.
- (2) That the Chairman of the Panel be requested to consult with Councillor D Louis, Essex County Council Cabinet Member for Highways and Transportation on the possible authorisation of the following scheme on the basis of a 7.5t weight restriction, at Oak Road, Rivenhall or Henry Dixon Road, Rivenhall
- (3) That, for clarity and monitoring purposes, all schemes recommended by the Panel for approval be included on an 'Approved Schemes' list with details of cost, progress and anticipated completion dates, and only removed once the scheme(s) have been completed.
- (4) That all schemes, including new schemes submitted for validation, be given a unique reference to ensure that the progress of the scheme may be monitored more accurately.
- (5) That a list of 'completed schemes' be created.

(4) That those schemes in each category which have a 'red' rating be transferred to a separate list on the basis that they are unlikely to be recommended for approval.

5 JUNCTION IMPROVEMENTS – SOUTH STREET/FAIRFIELD ROAD, BRAINTREE

INFORMATION: Consideration was given to a report on proposed improvements to the junction of South Street and Fairfield Road, Braintree to relieve congestion, improve passenger transport access and support regeneration. It was proposed that the improvements should be implemented in two phases: Phase 1 – demolition of 75 and 77 South Street, Braintree and Phase 2 – widening of the junction and removal of traffic lights. It was estimated that the scheme would cost £200,000.

DECISION: That proposed improvements to the junction of South Street and Fairfield Road, Braintree be recommended for approval.

6 SCHEMES APPROVED BY THE PANEL

DECISION: That the Schedule of Schemes recommended for approval at previous meetings of the Panel be noted.

7 HIGHWAY RANGERS – DEVOLUTION OF BUDGET TO PARISH COUNCILS

INFORMATION: Further to a reference made at the last meeting of the Panel, consideration was given to the possibility of part of the Rangers budget being devolved to Parish Councils. However, it was noted that Essex County Council's Cabinet Member for Highways and Transportation, Councillor D Louis, had indicated that it was for him to determine how the budget should be spent.

DECISION: That all Parish/Town Councils in the District be requested to identify potential schemes to be recommended to the Cabinet Member for Highways and

Transportation for implementation should any funding in the budget for 2012/13 remain unallocated.

8 **SECTION 106 AGREEMENTS**

DECISION: That the Schedule of Schemes to be funded by Section 106 Agreement contributions be noted.

9 SNOW CLEARING EQUIPMENT

INFORMATION: Consideration was given to a report on the proposed purchase of equipment to enable Braintree District Council to support Essex County Council's responsibility for snow clearance.

The equipment would be available for use throughout the District and could be adapted for use all year round.

DECISION: That capital funding of £3,120 for the purchase of a pedestrian controlled mechanical unit with a snow plough be recommended for approval.
